Commissioner Sharp seconded the motion. The Resolution was approved with all ayes.

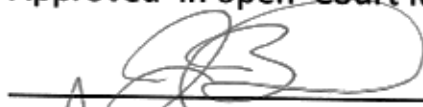

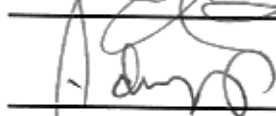
8. Discuss and take appropriate action Re: Texas Association of Counties Risk Management Pool Continuing Education for Treasurer Pam Smith.

10. Adjournment- All business complete Commissioner Sharp made the motion to adjourn. Commissioner Bryan seconded it. The motion was approved with all ayes.

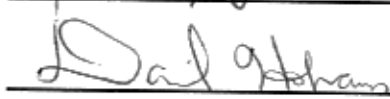
