


Pursuant to Section 81.005 (Terms of Court Meetings), Local Government Code, Vernon's Texas Codes Annotated, the Commissioners' Court by order shall designate a day of the week on which the Court shall convene in regular terms each month during the fiscal year.


The San Augustine County Commissioners' Court meeting shall be held at the San Augustine County Courthouse, 100 West Columbia St. San Augustine, Texas 75972, in the Commissioner Courtroom, First Floor, Room 103, of the San Augustine County Courthouse. Regular terms shall be held on the 2nd Tuesday and the 4th Tuesday of each month except on those months in which the Commissioners Court has designated as an official County Holiday. Unless otherwise noted. Court is set for 9:00 AM.




