**ORDER APPROVING AND ADOPTING SPECIAL BUDGET FOR USE OF GRANT OR
AID MONEY (SENATE BILL 22 FUNDS) PURSUANT TO TEX. LOC. GOV'T. CODE §111.0106**

WHEREAS, Chapter 111 of the Texas Local Government Code ("TEX. LOC. GOV'T. CODE") outlines the general budget making process of a county and requires the adoption of an annual budget by a county;

WHEREAS, TEX. LOC. GOV'T. CODE §111.0106 authorizes the adoption of a special budget by the commissioners court of a county for the limited purpose of spending grant or aid money for its intended purpose;

WHEREAS, the 1st Judicial District Attorney, Paul Robbins, has requested, and the Commissioners Court of San Augustine County, Texas has approved, the creation of a second assistant District Attorney position within the 1st Judicial District Attorney's Office:

WHEREAS, the 1st Judicial District Attorney's Office serves San Augustine County, Texas as a prosecuting office as defined by the Rural Law Enforcement Grant Program (Senate Bill 22);

WHEREAS, hiring additional staff in the office of a prosecuting attorney or increasing the salary of an assistant attorney, an investigator, or a victim assistance coordinator employed at a prosecuting attorney's office are permissible uses of Senate Bill 22 funds pursuant to the terms of the Rural Law Enforcement Grant Program:

WHEREAS, the 1st Judicial District Attorney's Office, which serves San Augustine County, Texas as a prosecuting office, is entitled to one hundred seventy-five thousand dollars in Senate Bill 22 funds for the 2025-2026 fiscal year;

WHEREAS, the 1st Judicial District Attorney's Office has remaining Senate Bill 22 funds available for disbursement in the amount of approximately forty-eight thousand three hundred eight dollars and forty cents (\$48,308.40) for the 2025-2026 fiscal year that were not included in an original budget and has requested the adoption of a special budget for use of these remaining Senate Bill 22 funds;


WHEREAS, pursuant to TEX. LOC. GOV'T. CODE §111.0106, the San Augustine County, Texas County Judge, Jeff Boyd, has certified availability of the remaining Senate Bill 22 funds to which the 1st Judicial District Attorney's Office is entitled for the 2025-2026 fiscal year that are available for disbursement in the amount of forty-eight thousand three hundred eight dollars and forty cents (\$48,308.40);


WHEREAS, the 1st Judicial District Attorney's Office desires to use its remaining Senate Bill 22 funds in the amount of approximately forty-eight thousand three hundred eight dollars and forty cents (\$48,308.40) to fund the second Assistant District Attorney position in the Office of the 1st Judicial District Attorney to fund both salary and associated benefits, if any, attributed to said position;


NOW, THEREFORE, BE IT RESOLVED AND ORDERED THAT the Commissioners Court of San Augustine County, Texas hereby approves and adopts a special budget as set forth in the attached Exhibit "A" in accordance with TEX. LOC. GOV'T. CODE §111.0106 for the purpose of using grant or aid money, specifically remaining Senate Bill 22 funds to which the 1st Judicial District Attorney's Office is entitled for the 2025-26 fiscal year, to fund the position of the second Assistant District Attorney in the 1st Judicial District Attorney's Office, including salary and any associated benefits, if any.


BE IT FURTHER RESOLVED AND ORDERED THAT the County Treasurer of San Augustine County, Texas is hereby authorized to release and expend any remaining and unallocated Senate Bill 22 funds to which the 1st Judicial District Attorney's Office is entitled for the 2025-2026 fiscal year to fund the second Assistant District Attorney position in accordance with the special budget adopted herein.
