**ORDER CREATING SECOND ASSISTANT DISTRICT ATTORNEY POSITION
IN OFFICE OF 1st JUDICIAL DISTRICT ATTORNEY AND AUTHORIZING
APPOINTMENT OF EMPLOYEE TO FILL POSITION**

WHEREAS, the creation of a position within local government by a district, county, or precinct officer that is not already in existence requires the approval of the commissioners court;

WHEREAS, Chapter 151 of the Texas Local Government Code ("TEX. LOC. GOV'T. CODE") recognizes the general employment authority of the commissioners court and authorizes the commissioners court of a county to adopt orders authorizing appointment of employees for the county;

WHEREAS, TEX. LOC. GOV'T. CODE Chapter 151 sets forth the method for a district, county, or precinct officer, including a district attorney which serves a county with a population of less than 190,000, to apply to the commissioners court for authority to appoint employees, including but not limited to deputies, assistants, or clerks, within his or her office to aid in the performance of their duties;

WHEREAS, TEX. LOC. GOV'T. CODE §151.003 provides that after the entry of an order of the commissioners court adopting the appointment of an employee, the officer applying for authority to appoint the employee is then entitled to do so;

WHEREAS, the Office of the 1st Judicial District Attorney serves San Augustine County, Texas and its citizens;

WHEREAS, the Office of the 1st Judicial District Attorney currently has one (1) Assistant District Attorney position to assist the District Attorney in the performance of his duties;

WHEREAS, the 1st Judicial District Attorney for San Augustine County, Texas, Paul Robbins, has submitted to the Commissioners Court of San Augustine County, Texas a sworn application in compliance with TEX. LOC. GOV'T. CODE §151.001 in which he requests the creation of a second Assistant District Attorney position to assist him and his Office in the performance of his/its duties; and

WHEREAS, the Commissioners Court of San Augustine County, Texas recognizes and acknowledges the necessity of and the benefit that the assistance of a second Assistant District Attorney in the Office of the 1st Judicial District Attorney would provide in serving San Augustine County, Texas and its citizens.

NOW, THEREFORE, BE IT RESOLVED THAT the Commissioners Court of San Augustine County, Texas approves the Application submitted by District Attorney Paul Robbins in which the creation of a second Assistant District Attorney position in the office of the 1st Judicial District Attorney has been requested;

BE IT FURTHER RESOLVED AND ORDERED THAT a second Assistant District Attorney position within the Office of the 1st Judicial District Attorney which serves San Augustine County, Texas be hereby created and established and said position is subject to appointment by the 1st Judicial District Attorney; and

BE IT FURTHER RESOLVED AND ORDERED THAT the Commissioners Court of San Augustine County, Texas authorizes the 1st Judicial District Attorney, Paul Robbins, to appoint a qualified person to fill the position of second Assistant District Attorney within the 1st Judicial District Attorney's Office.




